- All payroll deduct members must visit their accounts payable or human resources department at their place of employment to authorize a payroll deduction through us.
- Silver School memberships will need to update their memberships prior to summer vacation.
- Changes to a Silver School membership will not be authorized during the months of June, July and August.
- All employees MUST be full time or permanent. Seasonal employees must use other options.

## Freeport McMoran Membership Policy:

- Freeport McMoran pays for ½ of the membership cost for all Chino and Tyrone employees.
- The primary member must pay for ½ of the membership.
- Freeport McMoran **does not** pay for Reclamation Employees or Morenci.
- Reclamation and Morenci employees **do** qualify for this membership price:
  1. Need proof they are employed through Freeport McMoran.
  2. The employee is responsible for the full amount due on the membership.
- This is a six-month contract; *no changes on membership will be accepted during the contract* (i.e. upgrade or downgrade to a different membership or adding others on the membership).
- **Contract will terminate unless renewal form is filled out.**
